

China Single Entry Group (Port) Visa

1. Visa Application Service Fee

- USD\$100 per person

Note: A document fee of CNY 130 (cash only) will be required in China. Travelers not born in the USA or Canada may not be eligible for the group visa. In such cases, an individual visa might be required.

This visa type is currently valid only when traveling with specific airlines, including Hainan Airlines (**HU**), China Eastern Airlines (**MU**), China Southern Airlines (**CZ**), Air China (**CA**), XiamenAir (**MF**), Sichuan Airlines (**3U**), as well as Cathay Pacific (**CX**) and EVA Air (**BR**). **For other airlines, acceptance of this visa cannot be guaranteed at the moment, and applying for individual visa is recommended.**

2. Requirements

- Minimum of **2 travelers** per application.
- All members must **travel together**, entering and exiting China on the **same dates and flights**.
- Required documents must be submitted at least **45 days** prior to departure.
- **Colour-scanned copy** of the passport data page
- **A recent digital photo**

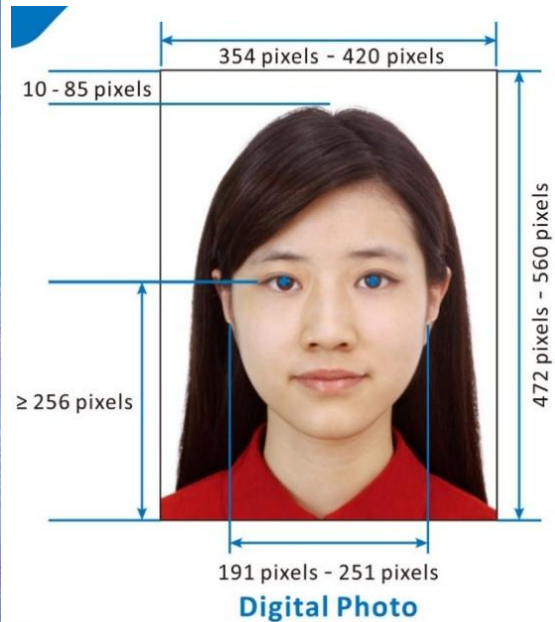
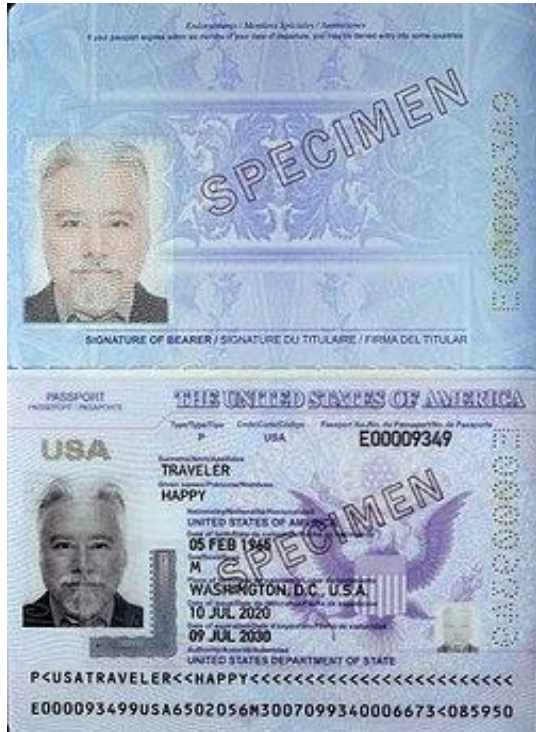
3. Passport Scanning Guidelines:

- Page must be **flat**, not folded or curved
- Ensure the **entire data page** (top and bottom sections) must be fully visible
- All **four corners** of the page must be shown and **clearly readable**
- Avoid **shadows, glare, or reflections**
- No **fingers, objects, or obstructions** in the image

4. Photo Specifications:

- **Image compression:** JPEG and the image file size: 40KB – 120KB
- **Face position:** Centered, facing forward
- **Expression:** Neutral (no smiling), eyes open, mouth closed and ears visible
- **Facial clarity:** No visible distortion
- **Eyeglasses:** Allowed only if not tinted or reflective
- No Hats or head coverings (unless for religious reasons)
- **Background:** White

5. Benefits

- Skip the paperwork, TripOppo will handle the application on your behalf
- No need to visit the Visa Center in person for the application.

*** Important Notes ***

- Visa applications begin 7–10 days prior to departure. The visa itself will be issued **3–4 days before departure**.
- Once the visa is issued, **TripOppo will send it by email** to the passengers.
- Passengers must **print the China Group Visa Notification** and **present it at the airline check-in counter**. All passengers listed on the same visa must **check in together** for both outbound and inbound flights.
